<b>RESOURCE CATEGORY</b>	Medical and Public Health
<b>RESOURCE KIND</b>	Personnel
<b>OVERALL FUNCTION</b>	The Social Worker helps people solve and cope with problems during a disaster, including providing treatment for emotional issues
<b>COMPOSITION AND ORDERING SPECIFICATIONS</b>	<ol style="list-style-type: none"> <li>1. This position can be ordered as a single resource or in conjunction with a NIMS typed team (Behavioral Health Community Services Team).</li> <li>2. Discuss logistics for deploying this position, such as security, lodging, transportation, and meals, prior to deployment</li> <li>3. This position typically works 12 hours per shift, is self-sustainable for 72 hours, and is deployable for up to 14 days</li> <li>4. Please refer to the NIMS 509: Behavioral Health Specialist if the primary mission assignment for this clinician includes an expectation for behavioral health services, or if the social worker holds a license for the practice of clinical social work</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

<b>DESCRIPTION</b>	<p>The Social Worker:</p> <ol style="list-style-type: none"> <li>1. Provides assessment, intervention, and referral recommendations to address a range of psychosocial and environmental needs</li> <li>2. Counsels clients to enhance, remediate, maintain, and restore clients' psychosocial functions</li> <li>3. Educates clients on mental health programs, processes, and long-term resources within the community</li> <li>4. Advocates for integrative approaches to disaster relief that promote normalization of the community and empowerment of the disaster survivor</li> </ol>	Not Specified
<b>EDUCATION</b>	Bachelor's Degree in social work from an accredited college or university	Not Specified
<b>TRAINING</b>	<p>Completion of the following:</p> <ol style="list-style-type: none"> <li>1. IS-100: Introduction to the Incident Command System, ICS-100</li> <li>2. IS-200: Incident Command System for Single Resources and Initial Action Incidents</li> <li>3. IS-700: National Incident Management System, An Introduction</li> <li>4. IS-800: National Response Framework, An Introduction</li> <li>5. Psychological First Aid (PFA) Training (minimum four hours)</li> </ol>	Not Specified
<b>EXPERIENCE</b>	Two years of experience in a practice setting commensurate with the mission assignment	Not Specified
<b>PHYSICAL/MEDICAL FITNESS</b>	<ol style="list-style-type: none"> <li>1. Performs duties under moderate circumstances characterized by working consecutive 12-hour days under physical and emotional stress for sustained periods of time</li> <li>2. Is able to work while wearing appropriate personal protective equipment (PPE) during shift</li> <li>3. Maintains immunizations in accordance with the U.S. Department of Health and Human Services Centers for Disease Control and Prevention's recommended adult immunization schedule for the United States of America</li> </ol>	PPE is mission-specific and may vary by working environment, including protective footwear, protective clothing for skin exposures, eye and hearing protection, respirators, gloves, and masks.

COMPONENT	SINGLE TYPE	NOTES
CURRENCY	1. Functions in this position during an operational incident, exercise, drill, or simulation at least once every five years 2. Immunizations up-to-date commensurate with mission assignment 3. Background checks as applicable law permits or requires	Provider must carry out and use any background checks as applicable law specifies. This may include a background check completed within past 12 months, sex offender registry check, and a local, state, and national criminal history.
PROFESSIONAL AND TECHNICAL LICENSES AND CERTIFICATIONS	State, the District of Columbia, or US territory-granted active status of legal authority to function as a Social Worker without restrictions	Not Specified
