OVERALL FUNCTION	The Fatality Management (FM) Morgue Escort physically accompanies and maintains security and control over a set of human remains from the Admitting Station until completion of morgue processing
COMPOSITION AND ORDERING SPECIFICATIONS	<ol style="list-style-type: none"> 1. This position can be ordered as a single resource. 2. This position can be ordered with a NIMS typed unit (Fatality Management Morgue Processing Unit). 3. Discuss logistics for deploying this position, such as working conditions, length of deployment, security, lodging, transportation, and meals, prior to deployment

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

Submits morgue reference number and morgue case file to the FM Morgue Admitting Specialist when processing is complete 5. Delivers processed remains to Human Remains Storage 6.
