OVERALL FUNCTION	The Fatality Management (FM) Forensic Photographer records the initial appearance of a potential crime scene and physical evidence in order to provide a permanent record of the event
COMPOSITION AND ORDERING SPECIFICATIONS	<ol> <li>This position can be ordered as a single resource or in conjunction with a NIMS typed team (Fatality Management Human Remains Recovery Team).</li> <li>This position can be ordered with a NIMS typed unit (Morgue Processing Unit).</li> <li>Discuss logistics for deploying this position, such as working conditions, length of deployment, security, lodging, transportation, and meals, prior to deployment</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

Serves as Lead for Forensic Photography station staff  2. Maintains still photography documentation of recovery sites, medical specimens, personal effects, postmortem examinations, and other medical procedures for diagnostic and legal purposes  3. Coordinates with the Morgue Processing Unit Leader to determine photographic requirements and the equipment (digital) and lighting necessary to capture the desired images  4. Carries out precision processing operations to generate high quality digital images or photographs  5. Ensures the recovery site number and morgue reference number (MRN) appear in every photograph taken  6. Maintains an accurate numbering system for each set of digital images  7. Provides security of each set of digital images  8. Depending on assignment, reports directly to the Morgue Processing Unit Leader (morgue) or the FM Human Remains Recovery Team Leader (field)	Not Specified
