| OVERALL FUNCTION | The Safety Officer monitors incident operations and advises the Incident Commander (IC) or Unified Command on all matters relating to operational safety, including the health and safety of incident personnel. |
| COMPOSITION AND ORDERING SPECIFICATIONS | <ol style="list-style-type: none"> 1. This position can be ordered as a single resource or in conjunction with a NIMS typed team (Incident Management Team). 2. Discuss logistics for deploying this position, such as working conditions, length of deployment, security, lodging, transportation and meals, prior to deployment. 3. Requestor specifies any additional qualifications necessary, based on incident complexity and needs. |

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

Conducts safety analyses and prepares reports on all incident facilities and locations, as necessary; communicates safety issues or concerns to incident personnel at shift briefings 7. Determines the need for subject matter experts or technical specialists to advise on or oversee unique safety issues or hazards, such as confined space, hazardous materials (HAZMAT), infectious diseases and so on 8. Assigns and oversees Assistant Safety Officers, technical specialists and subject matter experts, as necessary | Not Specified |

| PHYSICAL/MEDICAL FITNESS | Same as Type 2 | Same as Type 3 | Moderate | The NIMS Guideline for the NQS defines Physical/Medical Fitness levels for NQS positions. |
| CURRENCY | Functions in this position during a qualifying incident, planned event, exercise, drill or simulation at least once every two years | Same as Type 2 | Functions in this position or a higher position during a qualifying incident, planned event, exercise, drill or simulation at least once every two years | A higher position is one for which this position is a prerequisite. |
