OVERALL FUNCTION	The Public Works Supervisor leads a group of Equipment Operators or similar field or operations staff.
COMPOSITION AND ORDERING SPECIFICATIONS	<ol style="list-style-type: none">1. This position can be ordered as a single resource or in conjunction with a NIMS typed team (Public Works Support Team).2. Discuss logistics for deploying this position, such as working conditions, length of deployment, security, lodging, transportation and meals, prior to deployment.3. Requestor specifies any specialized licenses or endorsements necessary, such as a Class A commercial driver's license (CDL), based on incident needs.

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.
