COMPOSITION AND ORDERING SPECIFICATIONS	<ol style="list-style-type: none">1. This position can be ordered as a single resource or in conjunction with a NIMS typed team (Behavioral Health Community Services Team).2. Discuss logistics for deploying this position, such as security, lodging, transportation, and meals, prior to deployment3. This position typically works 12 hours per shift, is self-sustainable for 72 hours, and is deployable for up to 14 days4. Please refer to the NIMS 509: Behavioral Health Specialist if the primary mission assignment for this clinician includes an expectation for behavioral health services, or if the social worker holds a license for the practice of clinical social work

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

Advocates for integrative approaches to disaster relief that promote normalization of the community and empowerment of the disaster survivor	Not Specified

Maintains immunizations in accordance with the U.S. Department of Health and Human Services Centers for Disease Control and Prevention's recommended adult immunization schedule for the United States of America	PPE is mission-specific and may vary by working environment, including protective footwear, protective clothing for skin exposures, eye and hearing protection, respirators, gloves, and masks.

Immunizations up-to-date commensurate with mission assignment 3. Background checks as applicable law permits or requires	Provider must carry out and use any background checks as applicable law specifies. This may include a background check completed within past 12 months, sex offender registry check, and a local, state, and national criminal history.
