<b>DESCRIPTION</b>	<p>The Behavioral Health Chaplaincy Specialist:</p> <ol style="list-style-type: none"> <li>1. Coordinates information and liaises on family support service options with other appropriate agencies</li> <li>2. Meets with families and individuals who experience emotional or spiritual difficulties during disasters and emergency incidents</li> <li>3. Offers guidance to staff, emergency personnel, and the public during times of stress</li> <li>4. Works to coordinate activities and events for after-work hours for responders to ease the stresses of long work cycles</li> <li>5. Advocates for periods of respite and self-care, for responders and behavioral health caregivers, to ease the stresses of long work cycles</li> <li>6. Provides discretion and confidentiality of all verbal and written documentation concerning the deceased, next-of-kin (NOK), and family members</li> <li>7. Provides referral to other specialized resources, including behavioral health</li> <li>8. Delivers or accompanies law enforcement during death notifications</li> <li>9. Coordinates the inclusion of diverse cultural and religious values and traditions, as indicated by the spiritual and emotional needs of the impacted population</li> </ol>	Not Applicable

Maintains immunizations in accordance with the U.S. Department of Health and Human Services Centers for Disease Control and Prevention's recommended adult immunization schedule for the United States of America	Not Applicable

CURRENCY	1. Functions in this position during an operational incident, exercise, drill, or simulation at least once every five years 2. Ongoing, active participation with an established health care related providing entity such as a hospital, health system, agency, service, National Voluntary Organizations Active in Disaster (NVOAD), or private practice providing crisis intervention or disaster behavioral health expertise 3. Immunizations up-to-date commensurate with mission assignment 4. Background checks as applicable law permits or requires	Not Applicable
