

## FATALITY MANAGEMENT HUMAN REMAINS TRANSPORTATION STAGING SPECIALIST

<b>RESOURCE CATEGORY</b>	Medical and Public Health
<b>RESOURCE KIND</b>	Personnel
<b>OVERALL FUNCTION</b>	The Fatality Management (FM) Human Remains Transportation Staging Specialist directs and assists in the proper documentation of human remains transported from the disaster site to the morgue through a tracking database
<b>COMPOSITION AND ORDERING SPECIFICATIONS</b>	<ol style="list-style-type: none"> <li>1. This position can be ordered as a single resource or in conjunction with a NIMS typed team (Fatality Management Human Remains Recovery Team).</li> <li>2. Discuss logistics for deploying this position, such as security, lodging, transportation, and meals, prior to deployment</li> <li>3. This position typically works 12 hours per shift, is self-sustainable for 72 hours, and is deployable for up to 14 days</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

Directs and assists in the proper documentation of human remains transported from the disaster site to the morgue through a tracking database</li> <li>2. Locates and requests refrigerated transportation vehicles for storage and transportation of human remains and personal effects</li> <li>3. Manages inventory of transportation supplies such as body bags</li> <li>4. Provides a secure staging area</li> <li>5. Maintains chain of custody</li> <li>6. Coordinate with law enforcement for escort of remains to the morgue as necessary</li> <li>7. Identifies suitable cold storage areas for any excess storage needs</li> </ol>	Not Specified
