OVERALL FUNCTION	The Fatality Management (FM) Human Remains Transportation Staging Specialist directs and assists in the proper documentation of human remains transported from the disaster site to the morgue through a tracking database
COMPOSITION AND ORDERING SPECIFICATIONS	<ol style="list-style-type: none"> 1. This position can be ordered as a single resource or in conjunction with a NIMS typed team (Fatality Management Human Remains Recovery Team). 2. Discuss logistics for deploying this position, such as working condition, length of deployment, security, lodging, transportation, and meals, prior to deployment

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.
