This position can be ordered as a single resource or in conjunction with a NIMS typed team (Medical Countermeasure Point of Dispensing Management Team). 2. Discuss logistics for deploying this position, such as working conditions, length of deployment, security, lodging, transportation, and meals, prior to deployment

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

DESCRIPTION	<p>The MCM POD Management Team Leader:</p> <ol style="list-style-type: none"> 1. Manages, coordinates, and consults on overall MCM POD site functions, including operations, liaison, public information, security, safety, planning, logistics, and administration 2. Supervises MCM POD Management Team members, local public health personnel, volunteers, vendors, contractors, and other support personnel that support the dispensing operation/modality in numbers necessary to achieve dispensing goals commensurate with the target population 3. Oversees setup, management, and demobilization of all POD functions, including medical triage, access and functional needs (AFN), form completion and review, screening, dispensing, form collection, throughput management, and site security 4. Identifies, initiates, and oversees MCM dispensing strategies, such as execution of standard operating procedures 5. Manages and tracks Strategic National Stockpile (SNS) assets or other MCM supplies 6. Conducts briefings and provides just-in-time-training 7. Coordinates with the Authority Having Jurisdiction's (AHJ) POD Manager, SNS Branch Director, or equivalent if appropriate 	Not Specified
