

## FATALITY MANAGEMENT VICTIM INFORMATION CENTER TEAM LEADER

<b>RESOURCE CATEGORY</b>	Medical and Public Health
<b>RESOURCE KIND</b>	Personnel
<b>OVERALL FUNCTION</b>	The Fatality Management (FM) Victim Information Center (VIC) Team Leader establishes the VIC and if activated, manages a call center
<b>COMPOSITION AND ORDERING SPECIFICATIONS</b>	<ol style="list-style-type: none"> <li>1. This position can be ordered as a single resource or in conjunction with a NIMS typed team (Fatality Management Victim Information Team).</li> <li>2. Discuss logistics for deploying this position, such as security, lodging, transportation, and meals, prior to deployment</li> <li>3. This position typically works 6 hours per shift, is self-sustainable for 72 hours, and is deployable for up to 14 days</li> <li>4. In the absence of the FM VIC Team Leader, the VIC Information Collection Coordinator may assume the duties listed here</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

<b>DESCRIPTION</b>	<p>The FM VIC Team Leader:</p> <ol style="list-style-type: none"> <li>1. Establishes the VIC</li> <li>2. Manages a call center, if activated</li> <li>3. Reports directly to the FM Branch Director, Group Supervisor, or designee</li> <li>4. Ensures that team members properly interview families and acquaintances of victims using database forms</li> <li>5. Coordinates the exchange of information between the Morgue Identification Center (MIC), the Medical Examiner/Coroner (ME/C), and the VIC</li> <li>6. Coordinates with the FM Branch Director, Group Supervisor or designee, and local authorities to select a location for the VIC and call center, if activated</li> <li>7. Acts as liaison with the FM Disaster Portable Morgue Unit (DPMU) Communications Coordinator on form modifications, data collection techniques, and identifications made by the MIC Team and ME/C</li> <li>8. Monitors call volume surges and sets necessary staffing levels</li> <li>9. Directs the team's initial focus and resources to collecting missing persons data during database installation</li> <li>10. Assists the ME/C in providing current information about missing and deceased persons to the next of kin (NOK)</li> <li>11. Ensures that team members handle all verbal and written communication about the deceased, NOK, and family members with discretion and confidentiality</li> </ol>	Not Specified
<b>EDUCATION</b>	High school diploma or equivalent	The equivalent of a high school diploma is a certificate of high school equivalency.

Performs duties under moderate circumstances characterized by working consecutive 12-hour days under physical and emotional stress for sustained periods of time</li> <li>2. Maintains immunizations in accordance with the U.S. Department of Health and Human Services Centers for Disease Control and Prevention's (CDC) immunization recommendations</li> </ol>	Not Specified
<b>CURRENCY</b>	<ol style="list-style-type: none"> <li>1. Functions in this position during an operational incident, exercise, drill, or simulation at least once every five years</li> <li>2. Background checks as applicable law permits or requires</li> </ol>	Provider must carry out and use any background checks as applicable law specifies. This may include a background check completed within the past 12 months; a sex-offender registry check; and a local, state, and national driving and criminal history.
