Logistics for deploying this position (e.g., security, lodging, transportation, meals, etc.) should be discussed prior to deployment of this resource. 3. This position works up to 12 hours per shift, is self-sustained for 72 hours, and deployable for up to 14 days. 4. Specify when ordering if tribal experience and training are needed.

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

The HM Outreach Specialist provides technical assistance to advance mitigation activities by identifying need, opportunity, and resources available for engaging the public and other stakeholders. This position develops Community Education and Outreach (CEO) products and activities that support the adoption and implementation of the relevant HM Plans that are consistent with the associated HM strategy and any mitigation strategies developed for post-disaster recovery. The HM Outreach Specialist also provides advice and assistance on HM program concepts, rules, and processes in a variety of venues.	Not Specified
