Prepares, collects, evaluates, disseminates, and uses incident information to develop the Incident Action Plan (IAP)</li><li>4. Facilitates incident information to maintain situational awareness (current and future)</li><li>5. Provides periodic predictions on incident potential and incident course of actions</li><li>6. Coordinates planning efforts at the local level</li><li>7. Establishes or transitions into the Planning Section</li><li>8.
