| <b>COMPOSITION AND ORDERING SPECIFICATIONS</b> | <ol style="list-style-type: none"> <li>1. This position can be ordered as a single resource or in conjunction with a NIMS typed team (See note below).</li> <li>2. This resource can be ordered in conjunction with a NIMS typed team, including: Air Ambulance Fixed-Wing (Critical Care Transport), Air Ambulance Fixed-Wing (Non-Critical Care Transport), Air Ambulance Rotary-Wing (Critical Care Transport) or Air Ambulance Rotary-Wing (Non-Critical Care Transport)</li> <li>3. Discuss logistics for deploying this position, such as security, lodging, transportation, and meals, prior to deployment</li> <li>4. This position typically works 12 hours per shift, is self-sustainable for 72 hours, and is deployable for up to 14 days</li> <li>5. This position deploys with all necessary PPE, including flight and medical gear, based on the mission assignment</li> </ol> |

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.
