Coordinates investigations with local, state, and federal partners</li> <li>3. Performs diagnostics and renders safe procedures in Chemical, Biological, Radiological, Nuclear, and Explosives (CBRNE) events</li> <li>4. Conducts bomb crime scene investigations</li> <li>5. Collects and preserves evidence</li> <li>6. Provides technical support to special operations, dignitary protection, and special events</li> </ol>	Not Specified
