COMPOSITION AND ORDERING SPECIFICATIONS	<ol style="list-style-type: none"> 1. This position can be ordered in conjunction with a NIMS typed team (Mobile Field Force). 2. Discuss logistics for deploying this position, such as security, lodging, transportation, communications, and meals, prior to deployment 3. This position typically works 12 hours per shift, is self-sustainable for 72 hours, and is deployable for up to 7 days

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

DESCRIPTION	<p>The Mobile Field Force (MFF) Team Leader is a law enforcement manager (lieutenant or above) who has overall authority and responsibility for a pre-designated team capable of managing large crowds, site operations, and saturation patrols to maintain order and preserve the peace, and:</p> <ol style="list-style-type: none"> 1. Reports to the Operations Section Chief, Incident Commander (IC), or appropriate incident command authority 2. Coordinates with the Operations Section, Planning Section, and Logistics Section, as necessary 3. Plans and coordinates missions 4. Deploys personnel 5. Maintains situational awareness 6. Coordinates operations, such as: <ol style="list-style-type: none"> a. Incident Command Post and field operations center b. High-risk patrol operational tactics c. Deployment of less-lethal weapons d. Deployment of chemical agents and munitions e. Crowd control f. Supervising basic patrol operations g. Supervising critical incidents 7. Provides timely situation reports 8. Supports incident resolution 9. Completes after action reports 	Not Specified
EDUCATION	Law enforcement education and training that provides the core knowledge, skills, proficiency, and ability and meets the minimum requirements for employment as a sworn law enforcement officer team leader, with additional training in MFF command operations	Not Specified
