<b>COMPOSITION AND ORDERING SPECIFICATIONS</b>	<ol style="list-style-type: none"> <li>1. This position can be ordered as a single resource or in conjunction with a NIMS typed team (Waterborne Search and Rescue Team).</li> <li>2. Discuss logistics for deploying this position, such as security, lodging, transportation, and meals, prior to deployment</li> <li>3. This position typically works 12 hours per shift, is self-sustainable for 72 hours, and is deployable for up to 14 days</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

Rigs towing and mooring lines</li> <li>4. Acts as surface swimmer</li> <li>5. Administers first aid</li> <li>6. Operates damage control equipment</li> </ol>	Not Specified

<b>TRAINING</b>	<p>Completion of the following:</p> <ol style="list-style-type: none"> <li>1. IS-100: Introduction to the Incident Command System, ICS-100</li> <li>2. IS-800: National Response Framework, An Introduction</li> <li>5. First Aid (American Red Cross, American Heart Association, or equivalent)</li> <li>6. Completion of one of the following: <ol style="list-style-type: none"> <li>a. National Association of State Boating Law Administrators (NASBLA) Basic Crew Member course</li> <li>b. Maintains immunizations in accordance with the U.S. Department of Health and Human Services Centers for Disease Control's recommended adult immunization schedule for the United States of America</li> </ol>	Not Specified

<b>CURRENCY</b>	<ol style="list-style-type: none"> <li>1. Meets task-specific standards at least once every year, including the following: <ol style="list-style-type: none"> <li>a. Underway hours: 40 hours every year, 10 of which must be nighttime hours</li> <li>b. Mooring evolution</li> <li>c. Towing: one day and one night</li> <li>d. Basic Engineering Casualty Control Exercise: one set of drills</li> <li>e. Man overboard recovery: one day and one night</li> </ol> </li> <li>2. Meets task-specific standards at least once every two years, including the following: <ol style="list-style-type: none"> <li>a. Water survival exercise</li> <li>b. First aid training (such as for burns, hypothermia, shock, cardiopulmonary resuscitation (CPR), and bleeding)</li> </ol> </li> <li>3. Background checks as applicable law permits or requires</li> </ol>	Provider must carry out and use any background checks as applicable law specifies. This may include a background check completed within past 12 months; sex-offender registry check; and a local, state, and a local, state, and national criminal history.
