OVERALL FUNCTION	The Donations Coordination Task Force Leader has knowledge of all aspects of donations coordination and manages solicited and unsolicited goods, funds and services from the private sector and the public
COMPOSITION AND ORDERING SPECIFICATIONS	<ol style="list-style-type: none"> 1. This position can be ordered as a single resource or in conjunction with a NIMS typed team (Donated Goods Warehouse Management Team or Donations Coordination Task Force). 2. Requestor specifies any additional qualifications necessary based on incident complexity and needs 3. Discuss logistics for deploying this position, such as working conditions, length of deployment, security, lodging, transportation, and meals, prior to deployment 4. The position typically works 12 hours per shift, is self-sustainable for 72 hours and is deployable up to 14 days

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

Manages solicited and unsolicited goods, funds and services from the private sector and the public 4. Coordinates the flow of donated goods during the response and recovery phases 5. Maintains open communication with all stakeholders involved in donation operations 6. Supports the Public Information Officer (PIO) in developing press releases, public service announcements (PSA) and website updates 	Not Specified
