<b>OVERALL FUNCTION</b>	
<b>COMPOSITION AND ORDERING SPECIFICATIONS</b>	<ol style="list-style-type: none"> <li>1. This position can be ordered as a single resource or in conjunction with a NIMS typed team (such as Evacuation Coordination Team, Shelter Management Team, or Shelter Resident Services Team)).</li> <li>2. This position can be ordered with a NIMS typed unit (such as Feeding Services Unit)).</li> <li>3. Discuss logistics for deploying this position, such as security, lodging, transportation, and meals, prior to deployment</li> <li>4. This position typically works 12 hours per shift, is self-sustainable for 72 hours, and is deployable for up to 14 days</li> <li>5. Requestor indicates desired training or experience when ordering for duties that require special skills</li> <li>6. Requestor may specify any additional qualifications necessary based on incident complexity and needs</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

Performs a wide range of duties and operates proficiently in support of Mass Care/Emergency Assistance (MC/EA) operations, such as: <ol style="list-style-type: none"> <li>a. Feeding</li> <li>b. Reception center</li> <li>c. Respite</li> <li>d. Sheltering</li> <li>e. Distribution</li> <li>f. Evacuation</li> <li>g. Reunification</li> </ol> </li> <li>2. Works in shelters, in kitchens, on mobile distribution vehicles, at distribution sites, in warehouses, and at other MC/EA sites designated by the Authority Having Jurisdiction (AHJ)</li> <li>3. Performs specialty MC/EA functions, such as safe food handling for feeding operations.</li> </ol>	Not Specified
