



## DISASTER COST RECOVERY MANAGEMENT TEAM

<b>DESCRIPTION</b>	The Disaster Cost Recovery Management Team assists on disaster assessment and expense reimbursement pertaining to damage, emergency protective measures, and debris management for disaster recovery funding streams, such as insurance, Federal Emergency Management Agency (FEMA) Public Assistance, Federal Transit Administration Emergency Relief Program, Federal Highway Administration Emergency Relief Program, Community Development Block Grants - Disaster Recovery (CDBG-DR), and other Federal, state, tribal, territorial, and local programs. This team coordinates with and continues the National Incident Management System (NIMS) 508: Rapid Needs Assessment (RNA) Team's initial operations.
<b>RESOURCE CATEGORY</b>	Emergency Management
<b>RESOURCE KIND</b>	Team
<b>OVERALL FUNCTION</b>	The Disaster Cost Recovery Management Team assists in the post-RNA assessment and supports elements of disaster recovery needs and may interface with Federal, state, tribal, territorial, and local operations.
<b>COMPOSITION AND ORDERING SPECIFICATIONS</b>	<ol style="list-style-type: none"> <li>1. Discuss logistics for deploying this team, such as working conditions, length of deployment, security, lodging, transportation, and meals, prior to deployment</li> <li>2. Requestor may need to order hazard-specific specialists as single resources to supplement the team based on the incident, such as insurance, FEMA Public Assistance, or CDBG-DR specialists</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

Global Positioning System (GPS)(three per team)</li> </ol>	Consider alternate forms of communication, such as satellite phones, based on the mission assignment and team needs.
<b>GENERAL EQUIPMENT PER TEAM</b>	<ol style="list-style-type: none"> <li>1. 3 - Cameras</li> <li>2. 7 - Laptops</li> <li>3. Insurance and federal funding reference materials</li> <li>4.
