DESCRIPTION	This team provides the technical expertise, experience, and functional management for development of FEMA approvable pre- or post-disaster Hazard Mitigation Plans. This team can directly assist 1-4 communities simultaneously or assist a state in managing Hazard Mitigation Plan development for eligible communities statewide.

COMPOSITION AND ORDERING SPECIFICATIONS	1. 12-hour sustained operation 2. Specific individual personnel resources should be ordered as a separate resource 3. The ordering agency should authorize a planning team comprised of their staff, to match each planning resource personnel 1-to-1 with someone with comparable responsibilities (to carry out and carry on the planning initiatives)
