

## AREA COMMAND TEAM – FIREFIGHTING (NEW)

<b>DESCRIPTION</b>	The Area Command Team - Firefighting supports the area command, which may be activated to manage a very large incident with multiple Incident Management Teams
<b>RESOURCE CATEGORY</b>	Fire/Hazardous Materials
<b>RESOURCE KIND</b>	Team
<b>OVERALL FUNCTION</b>	<p>The Area Command Team - Firefighting:</p> <ol style="list-style-type: none"> <li>1. Provides oversight to multiple incidents rather than providing direct action on any one incident</li> <li>2. Manages multiple incident commanders to ensure that the overall objectives are being met, to set priorities among incidents, and to allocate scarce resources between incidents</li> <li>3. Coordinates conflicting objectives, strategies, priorities, and resource requests between incidents</li> </ol>
<b>COMPOSITION AND ORDERING SPECIFICATIONS</b>	<ol style="list-style-type: none"> <li>1. Discuss logistics for deploying this team, such as working conditions, length of deployment, security, lodging, transportation, and meals, prior to deployment</li> <li>2. Discuss the number of hours the team can operate and the number of operation days prior to deployment</li> <li>3. Area Command Teams, Firefighting may be established when incidents are close enough that oversight direction is required</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

<b>MANAGEMENT AND OVERSIGHT PERSONNEL PER TEAM</b>	1 - Area Commander (ACDR)	Not Specified
<b>SUPPORT PERSONNEL PER TEAM</b>	1 - Assistant Area Commander Planning (AAPC) 1 - Assistant Area Commander Logistics (AALC) 1 - Area Command Aviation Coordinator (ACAC) 2 - Area Command trainees	<ol style="list-style-type: none"> <li>1. Depending on the complexity of the incident, specialists in other areas such as aviation safety, information, long-term fire planning, and risk planning may also be assigned</li> <li>2. The ACDR identifies the type of trainee to be included in the Area Command Team, Firefighting based on incident requirements</li> </ol>
<b>PERSONAL PROTECTIVE EQUIPMENT (PPE) EQUIPMENT PER TEAM</b>	PPE is mission-specific and may vary by work environment. It includes protective footwear, protective clothing for skin exposure, eye and ear protection, respirators, gloves, and masks	Not Specified
<b>COMMUNICATIONS EQUIPMENT PER TEAM</b>	Not specified	Not Specified
